ROAD TRAFFIC AND VEHICLES

Public Service Vehicles (Amendment) Regulations (Northern Ireland) 1990

Made					29th May 1990
Coming into operation					9th July 1990

The Department of the Environment, in exercise of the powers conferred on it by Article 10(1) of the Transport (Northern Ireland) Order 1977(a), Articles 61(1), (4) and (5), 66(1) and 218(1) and (3) of the Road Traffic (Northern Ireland) Order 1981(b) and of all other powers enabling it in that behalf, makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Public Service Vehicles (Amendment) Regulations (Northern Ireland) 1990 and shall come into operation on 9th July 1990.

Amendment of the 1985 Regulations

- 2. The Public Service Vehicles Regulations (Northern Ireland) 1985(c) are amended as follows:
 - (1) In regulation 3(1) (interpretation)—
 - (a) insert at the appropriate places—
 - "'licensed for private hire" in relation to a taxi means licensed to carry passengers for hire but not for standing or plying for hire on a road or public place;";
 - "' "licensed for public hire" in relation to a taxi means licensed to stand or ply for hire on a road or public place;";
 - """multi-journey ticket" means a ticket authorising travel on a vehicle for more than one journey;"; and
 - (b) for the definition of "taxi" substitute—
 - "taxi" means a vehicle seating not more than six passengers in addition to the driver;".
 - (2) In regulation 6 (inspection of vehicle and grant of licence)—
 - (a) at the end of paragraph (2)(a) delete "and";
 - (b) at the end of paragraph (2)(b) for the comma substitute "; and; and
 - (c) after paragraph (2)(b) add—

- "(c) as regards taxis licensed for public hire and fitted with a taximeter, the requirements relating to plates referred to in regulation 39(2)(b)."
- (3) In regulation 13 (conditions of licence) delete "and" at the end of paragraph (i), delete the full stop and insert "; and" at the end of paragraph (j) and add the following new paragraph—
 - "(k) shall, on the sale or other change of ownership of a vehicle—
 - (i) forward the licence and disc in respect of it together with the name and address of the transferee to the nearest centre;
 - (ii) in the case of a taxi licenced for public hire also forward to the nearest centre the plates referred to in regulation 39(2)(b).".
- (4) For paragraph (1) of regulation 15 (transfer of licence) substitute the following paragraph—
 - "(1) On the sale or other change of ownership of a vehicle the Department may transfer the licence to the transferee.".
 - (5) For regulation 35(4) (testing, maintenance, etc.) substitute—
 - "(4) The owner or driver of a taxi fitted with a taximeter and licensed for public hire shall not use it for that purpose unless the taximeter complies with the provisions of paragraphs (1), (2) and (3).".
 - (6) For regulation 36(1) (sealing) substitute—
 - "(1) The owner or driver of a taxi fitted with a taximeter and licensed for public hire shall not use it for that purpose unless the taximeter is sealed in a manner approved by the Department.".
 - (7) For regulation 37(6) (construction) substitute—
 - "(6) The owner or driver of a taxi fitted with a taximeter and licensed for public hire shall not use it for that purpose unless the taximeter complies with the provisions of paragraphs (1) to (5).".
 - (8) In regulation 39 (markings on certain vehicles)—
 - (a) in paragraph (1) for the words "vehicle other than a taxi" substitute "bus";
 - (b) in paragraph (1)(b) delete the words "in the case of a bus,"; and
 - (c) for paragraph (2) substitute—
 - "(2) The owner or driver of a taxi fitted with a taximeter and licensed for public hire shall—
 - (a) exhibit in a conspicuous position in the vehicle a statement called "a fares board" displaying in legible letters and figures the fares which shall be paid by the passengers; and
 - (b) affix and keep affixed in a conspicuous position on the outside of the vehicle at the front and rear a plate supplied by the Department as illustrated in Schedule 10.".
 - (9) After regulation 39 insert—
 - "Roof signs
 - **39A.**—(1) Subject to paragraph (5) the owner or driver of a taxi licensed for public or private hire, as the case may be, shall not use it for

that purpose unless there is displayed a sign which is mounted on and fixed safely to the roof of the vehicle and which complies with the requirements of paragraphs (2), (3) and (4).

- (2) The sign shall—
- (a) be fitted so as not to cause danger to a person in the vehicle or a person entering or alighting from the vehicle or on a road;
- (b) be mounted centrally and positioned transversely when viewed from the front of the vehicle;
- (c) not overhang the roof or measure less than 750mm across but may occupy the breadth of the roof;
- (d) not project more than 250mm above the highest part of the roof;
- (e) subject to paragraph (3) display to the front on a white background in clear and legible black letters the licensee's name or trading name or the word "Taxi";
- (f) display to the rear a telephone number only;
- (g) subject to paragraph (3) be illuminated internally during the hours of darkness to show a steady white light to the front and a steady red light to the rear;
- (h) be fused at source against electrical short circuit; and
- (i) not cause dazzle or discomfort to other road users.
- (3) In the case of a taxi licensed for public hire and used for that purpose outside the City of Belfast—
 - (a) the background referred to in paragraph (2)(e) shall be amber instead of white; and
 - (b) the light shown to the front referred to in paragraph 2(g) shall be amber instead of white.
- (4) No person shall place anything on the roof of a taxi which shall have the effect of obscuring the sign.
 - (5) This regulation shall not apply to a taxi—
 - (a) which is being used for the purpose of a wedding, funeral or for purposes in connection with the Northern Ireland Civil Service, industry or commerce;
 - (b) which is fitted with a taximeter and used from a taxi stand in the City of Belfast; or
 - (c) which conforms to the following specifications—
 - (i) it has a saloon body with a solid partition separating the driver's seat from the passengers' compartment, the partition extending from the floor to the roof and fitted with a sliding window which can be opened by the passengers;
 - (ii) the height inside the passengers' compartment is at least 1.21 metres from the floor to the roof and the distance from the partition to the front of the cushion of the back seat at least 0.76 metres:
 - (iii) the back seat cushion measures at least 0.45 metres from front to rear; and.

- (iv) there are separate entrances to the driver's and passengers' compartments.".
- (10) In regulation 41 (fire extinguishing apparatus)—
- (a) delete paragraph (3); and
- (b) re-number paragraph (4) as paragraph (3).
- (11) For regulation 47 (conduct of driver) substitute—
- "Conduct of drivers and other persons employed in connection with vehicles
- 47.—(1) A driver shall not, when a vehicle is in motion, hold a microphone unless it is necessary for him, either in an emergency or on grounds of safety, to speak into the microphone.
- (2) Subject to paragraph (3) a driver shall not, when a vehicle is in motion, speak to any person either directly or by means of a microphone.
- (3) The prohibition in paragraph (2) shall not apply to the driver of a vehicle—
 - (a) speaking in circumstances where he is obliged to do so by reason of an emergency or on grounds of safety;
 - (b) speaking to the operator or a person authorised by the operator in relation to the location, progress or working of the vehicle and is doing so without being distracted from his driving of the vehicle; or
 - (c) which is being used to provide a service which is not an excursion or tour, making short statements from time to time in relation to the location, progress or working of the vehicle and is doing so without being distracted from his driving of the vehicle.
 - (4) A driver or other person employed in connection with vehicles—
 - (a) shall conduct himself in an orderly manner and with civility and propriety towards passengers and intending passengers; and
 - (b) shall not, without reasonable excuse, refuse or neglect to comply with any proper request from passengers or intending passengers.
 - (5) In this regulation—
 - (a) "operator" means the holder of a licence under Article 61 of the Order in respect of the vehicle; and
 - (b) "excursion or tour" means a service for the carriage of passengers by road at separate fares on which the passengers travel on a journey, with or without breaks, from one or more places to one or more other places and back or a service the primary purpose of which is sightseeing.".
- (12) In regulation 50(2) (smoking) delete the words "Except where a vehicle is let on hire for a specific sum,".
 - (13) In regulation 51 (conduct of passengers)—
 - (a) at the end of paragraph (1)(g) delete the full stop, insert a semi-colon and add the following sub-paragraphs—
 - "(h) travel on the upper deck of a vehicle unless he occupies a seat provided for passengers;

- (i) except with the permission of the owner of the vehicle, sell or offer anything for sale;
- (j) play or operate any musical instrument or sound reproducing equipment to the annoyance of other persons; or
- (k) consume alcohol."; and
- (b) paragraph (2) shall cease to have effect.
- (14) In regulation 52(1) (fares and tickets) for sub-paragraph (b) substitute—
 - "(b) pay to the driver on entering the vehicle the correct fare or proffer a multi-journey ticket for the journey he intends taking;".
 - (15) In regulation 57 (contravention of regulations 50 to 56)—
 - (a) after 57 insert "-(1)"; and
 - (b) add the following paragraph—
 - "(2) A passenger who is reasonably suspected by the driver of contravening regulations 50 to 56 shall give his name and address to a police constable or the driver.".
 - (16) For regulation 60 substitute—
 - "60. Any property not claimed within a period of 3 months shall be sold.".
 - (17) For regulation 61(1) (wearing of badges by taxi drivers) substitute—
 - "(1) While a taxi is being used for public or private hire but not in connection with a wedding or a funeral, the driver shall wear a badge supplied by the Department.".
 - (18) After item 11.1 of Schedule 3 add—
 - "11.2 Plates (where appropriate)
 - 11.3 Roof signs (where appropriate)".
 - (19) In Part I of Schedule 4 for the first 4 lines substitute—
 - "LICENCE FOR A TAXI TO STAND OR PLY FOR HIRE ON A
 ROAD OR PUBLIC PLACE

(20) For Schedule 8 substitute—

"SCHEDULE 8

(See regulation 41(2))

FIRE EXTINGUISHING APPARATUS

A fire extinguisher which complies in all respects with the specification for portable fire extinguishers issued by the British Standards Institution numbered BS 5423: 1977 or BS 5423: 1980 or BS 5423: 1987 and which—

- (a) has a minimum test rating of 8A or 21B, and
- (b) contains water or foam or contains, and is marked to indicate that it contains, halon 1211 or halon 1301.".
- (21) In Schedule 9 (discs for buses and taxis)—
- (a) for the heading of Part II substitute—
 "DISC FOR A TAXI LICENSED TO STAND OR PLY FOR HIRE ON A ROAD OR PUBLIC PLACE"; and
- (b) for the heading of Part III substitute—
 "DISC FOR A TAXI LICENSED TO CARRY PASSENGERS FOR HIRE BUT NOT TO STAND OR PLY FOR HIRE ON A ROAD OR PUBLIC PLACE".
- (22) After Schedule 9 add-

"SCHEDULE 10 (See regulation 39(2)(b))

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Public Service Vehicles Regulations (Northern Ireland) 1985.

The principal amendments are—

- 1. To require, as a condition of his licence, that the licensee, on sale or other change of ownership of a vehicle, shall forward the disc as well as the licence (and plates if appropriate) to the nearest vehicle inspection centre (regulation 2(3)).
- 2. To require that taxis fitted with a taximeter and licensed for public hire shall display the seating capacity on plates which—
 - (a) shall be in the form illustrated in a new Schedule 10; and
 - (b) are affixed in a conspicuous position to the outside of the vehicle at the front and rear (regulation 2(8) and (22)).
- 3. To require, subject to certain exemptions, that taxis, licensed for public or private hire, when used for such purposes shall display a sign which—
 - (a) is fixed safely to the roof of the vehicle and when viewed from the front is in a central transverse position;
 - (b) displays to the front on a white background (in the case of taxis licensed for public hire and used outside Belfast an amber background) in clear and legible black letters the licensees' name or trading name or the word "Taxi";
 - (c) displays to the rear only a telephone number;
 - (d) is illuminated internally during the hours of darkness;
 - (e) shows a steady white light to the front and a steady red light to the rear except in the case of a taxi licensed for public hire and used outside the City of Belfast when the light to the front shall be amber; and
 - (f) is not obscured by anything placed on the roof of the vehicle (regulation 2(9)).

4. To prohibit—

- (a) the holding of a microphone by a driver whilst his vehicle is in motion unless it is necessary either in an emergency, or for safety to speak into the microphone;
- (b) the driver speaking directly or through a microphone to any person except—
 - (i) in an emergency or on grounds of safety,
 - (ii) in relation to the location, progress or working of the vehicle, to a person authorised by the operator of the vehicle, or
 - (iii) to the passengers by way of brief and occasional comments on the location, progress or working of the vehicle.

The exception mentioned in sub-paragraph (b)(iii) shall not apply when the service being provided is an excursion or a tour (regulation 2(11)).

5. To prohibit passengers—

- (a) smoking where a prohibition notice is exhibited: the exception where a vehicle is let for a specific sum is removed;
- (b) travelling on the upper deck of a vehicle unless occupying a seat;
- (c) selling or offering anything for sale except with the permission of the owner of the vehicle;
- (d) playing or operating any musical instrument or sound reproducing equipment to the annoyance of other persons; or
- (e) consuming alcohol: the exception where a vehicle is let on hire for a specific sum is removed (regulation 2(12) and (13)).
- 6. To require a passenger, suspected by the driver of contravening regulations 50 to 56, to give his name and address to a police constable or the driver (regulation 2(15)).
- 7. To remove the requirement that the sale of lost property shall be by public auction (regulation 2(16)).

Any person in breach of the Regulations shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (currently £400).

The opportunity has also been taken to make some drafting amendments.
