## CREDIT UNIONS

**Credit Unions (Fees) Regulations (Northern Ireland) 1990**

*Made* . . . . . 18th September 1990

*Coming into operation* . . . . . 29th October 1990

The Department of Economic Development, in exercise of the powers conferred on it by Articles 31(2) and (3) and 78(1) of the Credit Unions (Northern Ireland) Order 1985(a) and of every other power enabling it in that behalf, hereby makes the following Regulations:

*Citation and commencement*

1. These Regulations may be cited as the Credit Unions (Fees) Regulations (Northern Ireland) 1990 and shall come into operation on 29th October 1990.

*Fees*

2. The fees specified in the Schedule shall be payable to the registrar in respect of the matters specified therein.

*Revocation*

3. The Credit Unions (Fees) Regulations (Northern Ireland) 1989(b) are hereby revoked.

**Scale of fees payable for the inspection, or the furnishing of copies, of documents in the custody of the registrar or in connection with the exercise by the registrar of any of his functions under the Credit Unions (Northern Ireland) Order 1985, herein referred to as "the Order".**

## EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations supersede the Credit Unions (Fees) Regulations (Northern Ireland) 1989.

The Regulations generally increase by between 5% and 10% the fees to be paid in connection with the exercise by the registrar of friendly societies of functions under the Credit Unions (Northern Ireland) Order 1985 or for the inspection, or furnishing of copies, of documents in the custody of the registrar. However the fee for the signature of the registrar on any document required to be signed by him, not chargeable with any other fee, and the fee for the provision of a photocopy or extract of a document held on a public file have been increased by 33%. The fee for the examination and certification of a copy of a document held on such a file where the certified copy is not made by the registrar has been omitted. The fee for the reference of a dispute to the registrar has not been increased.
