ROAD TRAFFIC AND VEHICLES

Public Service Vehicles (Licence Fees) (Amendment)
Regulations (Northern Ireland) 1991

Made 20th March 1991

Coming into operation 1st April 1991

The Department of the Environment, in exercise of the powers conferred on it by Articles 2(2)(a), 61(1), 66(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(b) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(c) as regards regulation 2, makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Public Service Vehicles (Licence Fees) (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 1st April 1991.

Amendment of the 1985 Regulations

2. In Schedule 7 to the Public Service Vehicles Regulations (Northern Ireland) 1985(d)—

- (a) in paragraphs 1(b) and 2(b) for “£38·00” substitute “£40·60”;
- (b) in paragraphs 1(c) and 2(c) for “£26·50” substitute “£28·30”;
- (c) in paragraph 3(b) for “£18·75” substitute “£20·00”;
- (d) in paragraph 3(c) for “£13·25” substitute “£14·20”;
- (e) in paragraph 4(b) for “£8·25” substitute “£8·80”;

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Public Service Vehicles Regulations (Northern Ireland) 1985 by increasing the fee payable—

- (1) for an application or re-application (following a refusal) for a licence for a bus carrying more than 12 passengers from £38·00 to £40·60 and for a bus carrying 12 passengers or less from £26·50 to £28·30;
- (2) from £18·75 to £20·00 (bus carrying more than 12 passengers) and from £13·25 to £14·20 (bus carrying 12 passengers or less) where re-application is made within 21 days from the date of service of a notice of refusal and the bus is presented for re-inspection on a date appointed by the Department; and
- (3) for a duplicate vehicle licence for a bus from £8·25 to £8·80.
