## HEALTH AND SAFETY

**Asbestos (Licensing) (Fees Amendment) Regulations  
(Northern Ireland) 1991**

*Made* . . . . . 4th April 1991

*Coming into operation* . . . . . 3rd June 1991

The Department of Agriculture, the Department of Economic Development and the Department of the Environment acting jointly as the Department concerned(a) in exercise of the powers conferred by Article 40(2) and (4) of the Health and Safety at Work (Northern Ireland) Order 1978(b) and of every other power enabling them in that behalf, after consultation in accordance with Article 46(1) of that Order with the Health and Safety Agency for Northern Ireland and such other bodies as appear to them to be appropriate, hereby make the following Regulations:—

*Citation and commencement*

1. These Regulations may be cited as the Asbestos (Licensing) (Fees Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 3rd June 1991.

*Amendment of the Asbestos (Licensing) Regulations (Northern Ireland) 1984*

2. For paragraph (6) of regulation 4 of the Asbestos (Licensing) Regulations (Northern Ireland) 1984(c) there shall be substituted—

“(6) A fee of £375 shall be payable by the applicant to the Department on each application being made for a licence under this regulation.”.

*Revocation*

3. The Asbestos (Licensing) (Fees Amendment) Regulations (Northern Ireland) 1989(d) are hereby revoked.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations amend the Asbestos (Licensing) Regulations (Northern Ireland) 1984 so as to change the structure and increase the rate of fee payable to the Department of Economic Development by an applicant for a licence under regulation 4 of those Regulations for work with asbestos insulation or asbestos coating.

The fees of £150 payable on first application for a licence and £75 payable, subject to certain conditions, for renewal of a licence, are both replaced by a single fee of £375, payable on application for any licence.

The Asbestos (Licensing) (Fees Amendment) Regulations (Northern Ireland) 1989 are revoked.
