## SALARIES

**Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1991**

*Made* . . . . . 5th June 1991

*Coming into operation* . . . . . 23rd July 1991

*To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974*

In exercise of the powers conferred by Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973(a) and now vested in me(b) and of all other powers enabling me in that behalf, I hereby make the following Order:

*Title and commencement*

1. This Order may be cited as the Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1991 and shall come into operation on 23rd July 1991.

*Revocation*

2. The Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1990(c) is hereby revoked.

*Increase in salaries*

3. The annual salaries payable to the Parliamentary Commissioner and the Commissioner for Complaints shall be increased as follows—

- (a) from £50,900 to £55,420 from 1st April 1991;
- (b) from £55,420 to £56,430 from 1st December 1991.

This Order provides for increases in the annual salaries payable to the Northern Ireland Parliamentary Commissioner for Administration and the Northern Ireland Commissioner for Complaints following recommendations made in the Report of the Review Body on Top Salaries in 1991 (HMSO Cm 1413).

These increases are made with retrospective effect from 1st April 1991 under Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973.

Article 2 revokes the Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1990.
