**The Insolvency (1989 Order) (Commencement No. 3) Order
(Northern Ireland) 1991**

Made 9th July 1991

The Department of Economic Development, in exercise of the powers conferred on it by Article 1(2) of the Insolvency (Northern Ireland) Order 1989(a), read with paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b), and of every other power enabling it in that behalf, hereby makes the following Order:

Citation

1. This Order may be cited as the Insolvency (1989 Order) (Commencement No. 3) Order (Northern Ireland) 1991.

Commencement

2. Part XII, Articles 355 to 357 and Article 363 of the Insolvency (Northern Ireland) Order 1989 shall come into operation on 9th July 1991.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order brings into operation provisions of the Insolvency (Northern Ireland) Order 1989 relating to insolvency practitioners.

- Those provisions enable the Department of Economic Development —
- (1) to make an order recognising the professional bodies which may authorise certain of their members to act as insolvency practitioners;
 - (2) to authorise individuals to act as insolvency practitioners; and
 - (3) to make regulations relating to insolvency practitioners.

It also brings into operation those provisions of the Insolvency (Northern Ireland) Order 1989 which enable the Department of Economic Development to appoint official receivers and deputy official receivers.
