HEALTH AND PERSONAL SOCIAL SERVICES.

Appointment of Consultants (Amendment) Regulations
(Northern Ireland) 1991

Made 25th July 1991

Coming into operation 5th August 1991

The Department of Health and Social Services in exercise of the powers conferred on it by Articles 16(3), 89(1), 106(b), 107(6) of and paragraph 12(2) of Schedule 1 to the Health and Personal Social Services (Northern Ireland) Order 1972(a) and of every other power enabling it in that behalf and in conjunction with the Department of Finance and Personnel(b) hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Appointment of Consultants (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 5th August 1991.

Amendment of the Appointment of Consultants Regulations (Northern Ireland) 1991

2.—(1) The Appointment of Consultants Regulations (Northern Ireland) 1991(c) shall be amended in accordance with the following paragraphs.

(2) In regulation 4 (exempted appointments)—

(a) in sub-paragraph (f), for the word “service” there shall be substituted “services”;

(b) in sub-paragraph (g), for the words “Dental Act” there shall be substituted “Dentists Act”.

(3) In Schedule 1 (Consultant Panel) in paragraph 1(a)(ii) after the word “practitioners” there shall be added the words “or dental practitioners in the case of a dental appointment”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Appointment of Consultants Regulations (Northern Ireland) 1991 ("the principal regulations").

Regulation 2 amends paragraph 1(a)(ii) of Schedule 1 to the principal regulations to include provision for the nomination to Consultants' Appointments Panels of 2 dental practitioners in the case of dental appointments. There are also 2 minor amendments to regulation 4 of the principal regulations.
