### The Food Safety (Exports) Regulations (Northern Ireland) 1991

1st August 1991 Made 9th September 1991 Coming into operation

The Department of Health and Social Services and the Department of. Agriculture, being the Department concerned(a), in exercise of the powers conferred by Articles 15(1), (2) and (3), 16(1), 25(1) and (3) and 47(2) of, and paragraph 1 of Schedule 1 to, the Food Safety (Northern Ireland) Order 1991(b) and of all other powers enabling them in that behalf and after consultation in accordance with Article 47(3) of that Order with such organisations as appear to them to be representative of interests likely to be substantially affected by these Regulations, hereby makes the following Regulations:

### Citation and commencement

1. These Regulations may be cited as the Food Safety (Exports) Regulations (Northern Ireland) 1991 and shall come into operation on 9th September 1991.

# Amendment of existing food related Regulations

2.—(1) After the last regulation in each of the Regulations specified in columns 1 and 2 of the Schedule there shall be inserted the following regulation numbered sequentially—

# "Defences in relation to exports

In any proceedings for an offence under these Regulations it shall be a defence for the person charged to prove that the food in respect of which the offence is alleged to have been committed—

- (a) was intended for export and complied with the importing country's domestic legislation relevant to the alleged offence; or
- (b) was intended for export and was prepared and labelled for sale before 9th September 1991.".
- (2) The provisions of the Regulations, if any, specified in column 3 of the Schedule shall be revoked.

Amendment of the Materials and Articles in Contact with Food Regulations (Northern Ireland) 1987

- 3.—(1) After regulation 22 of the Materials and Articles in Contact with Food Regulations (Northern Ireland) 1987(a) there shall be inserted the following regulation—
  - "Defences in relation to exports
  - 23. In any proceedings for an offence under these Regulations it shall be a defence for the person charged to prove that the material or article in respect of which the offence is alleged to have been committed—
    - (a) was intended for export and complied with the importing country's domestic legislation relevant to the alleged offence; or
    - (b) was intended for export and was prepared and labelled for sale before 9th September 1991.".
  - (2) Regulation 3(c) of those Regulations shall be revoked.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations.)

These Regulations implement Articles 2 and 3 of Council Directive 89/397/EEC (O.J. No. L186, 30.6.89, p. 23), on the approximation of the laws of the Member States relating to food and materials and articles intended to come into contact with food, as read with the ninth recital to that Directive.

The Regulations replace provisions excluding food destined for export from each of the Regulations (except the Arsenic in Food Regulations (Northern Ireland) 1961 and the Milk Regulations (Northern Ireland) 1987) listed in the Schedule by a defence relating to offences under those Regulations. The defence is available to a person who proves that the food, in respect of which the offence is alleged to have been committed, was intended for export and complied with the importing country's relevant legislation. There is a transitional provision to cover food intended for export which has been prepared and labelled for sale before 9th September 1991, when the Regulations come into operation. The Regulations replace an export exclusion by a similar defence and transitional provision in the Materials and Articles in Contact with Food Regulations (Northern Ireland) 1987, as amended.

The Regulations also add a similar defence and transitional provision to the Arsenic in Food Regulations (Northern Ireland) 1961 and the Milk Regulations (Northern Ireland) 1987.
