# Poultry Feedingstuffs (Amendment) Order (Northern Ireland) 1991

Made . . . . . . 8th August 1991

Coming into operation . . 31st August 1991

The Department of Agriculture, in exercise of the powers conferred on it by Articles 5(1), 19(e) and 60(1) of the Diseases of Animals (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, hereby makes the following Order:

### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Poultry Feedingstuffs (Amendment) Order (Northern Ireland) 1991 and shall come into operation on 31st August 1991.
- (2) In this Order "the principal Order" means the Poultry Feedingstuffs Order (Northern Ireland) 1991(b).

# Amendment of the principal Order

- 2. The principal Order shall be amended as follows:—
- (a) in Article 4(1) (exemptions from the provisions of Article 3) for "on or before 31st August 1991" there shall be substituted "on or before 31st December 1991"; and
- (b) in Part I of the Schedule (heat treatment) for "a minimum temperature of 70°C" there shall be substituted "a minimum temperature of 75°C".

# Transitional provisions

- 3.—(1) Any feedingstuffs which, before 31st August 1991, were treated in accordance with Part I of the Schedule to the principal Order as it had effect immediately before that date shall, for the purposes of that Order, be treated as if they were processed.
- (2) In paragraph (1) "feedingstuffs" and "processed" shall have the meanings respectively assigned to them by Article 2 of the principal Order.

#### **EXPLANATORY NOTE**

(This note is not part of the Order.)

The Poultry Feedingstuffs Order (Northern Ireland) 1991 ("the principal Order") prohibits the feeding to poultry, or the sale and supply for that purpose, of any feedingstuffs which have not been processed in accordance with Part I of the Schedule to that Order. However the principal Order permitted the feeding to poultry, or the sale and supply for that purpose, of feedingstuffs which had not been so processed where it was manufactured on or before 31st August 1991 provided certain conditions regarding its collection, holding and removal were observed. This Order amends the principal Order by—

- (a) extending the exemption to any feedingstuffs manufactured on or before 31st December 1991; and
- (b) increasing the minimum temperature at which feedingstuffs must be processed for one minute from 70°C to 75°C at the core.

The Order also makes transitional provisions so that feedingstuffs treated in accordance with Part I of the Schedule to the principal Order before this Order came into operation will continue to be regarded as having been processed.
