REGISTRATION OF DEEDS

Registration of Deeds (Fees) Order (Northern Ireland) 1991

7th January 1991 Made Coming into operation 4th March 1991

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

The Department of the Environment, in exercise of the powers conferred by section 16(1) of the Registration of Deeds Act (Northern Ireland) 1970(a) and now vested in it(b) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Registration of Deeds (Fees) Order (Northern Ireland) 1991 and shall come into operation on 4th March 1991.

Interpretation

- 2. In this Order—
- "matrimonial charge" has the same meaning as in Article 5(1) of the Family Law (Miscellaneous Provisions) (Northern Ireland) Order 1984(c):
- "Matrimonial Charges Index" has the same meaning as in regulation 3(2) of the Matrimonial Charges Regulations (Northern Ireland) 1989(d).

Fees

3. The fees to be taken in the registry of deeds in respect of the matters set out in column 1 of the Schedule shall be those set out opposite thereto in column 2 of that Schedule.

Exemption from payment of fees

4. A government department (including a department of the Government of the United Kingdom) shall not be required to pay the fee specified in the Schedule where that department furnishes to the registry of deeds a certificate that the registration required or entry, search, examination, inspection,

certificate or copy made or other matter done in that registry under the Registration of Deeds Acts is required for the public service.

Revocation

5. The Registration of Deeds (Fees) Order (Northern Ireland) 1986(a) is hereby revoked.

Registration of Deeds EXPLANATORY NOTE

(This note is not part of the Order.)

This Order which comes into operation on 4th March 1991 increases the fees to be taken in respect of documents lodged for registration in the registry of deeds and for other matters done in that registry. The average amount of the increase is in the region of 66 per cent ranging from an increase from £3 to £4 for copies of certain documents made in the registry to an increase from £3.50 to £10 for every special certificate of registration.

The Order also provides for the payment of—

- (a) fees for services related to matrimonial charges;
- (b) a fee for a copy of an abstract of a memorial, affidavit of judgment or particulars of a document relating to a matrimonial charge included in a statement of a common search or a certificate of a negative search; and
- (c) a fee for a copy made by the registry of deeds of any document held by it under the Registration of Deeds Acts and for which a fee has not otherwise been provided for in the Order.

The Registration of Deeds (Fees) Order (Northern Ireland) 1986 is revoked.
