## Further Education Teachers' Salaries (Amendment No. 2) **Regulations (Northern Ireland) 1991**

The Department of Education, in exercise of the powers conferred on it by Articles 69(1) and (2) and (3)(a), 70(1)(b)(b) and 134(1) of the Education and Libraries (Northern Ireland) Order 1986(c), and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(d), and of every other power enabling it in that behalf, after consultation in accordance with Article 69(5)(a) of the Education and Libraries (Northern Ireland) Order 1986(c) hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Further Education Teachers' Salaries (Amendment No. 2) Regulations (Northern Ireland) 1991 and shall come into operation on 27th September 1991 and shall have effect on and from 1st September 1991.

Amendment to the Further Education Teachers' Salaries Regulations (Northern Ireland) 1988

2. The Further Education Teachers' Salaries Regulations (Northern Ireland) 1988(e) shall be amended as follows---

- (a) in regulation 10 (head of department) for the sums "£2,172" and "£1,926" there shall be substituted "£2,304" and "£2,043" respectively;
- (b) in regulation 18(1) (payment of unqualified teachers) for "£6,513" there shall be substituted "£6,909";
- (c) in regulation 19(2) (payment of part-time teachers) for the sums "£20.12", "£17.16" and "£12.61", there shall be substituted "£21.35", "£18.21" and "£13.38" respectively;

- (d) in regulation 25 (teachers in service on 31st August 1990) for "31st August 1990" there shall be substituted "31st August 1991";
- (e) in Schedule 1 (salary scales and ranges of salary)—
  - (i) for paragraphs 1, 7, 8, 9 and 10 there shall be substituted respectively the paragraphs 1, 7, 8, 9 and 10 set out in the Schedule to these Regulations;
  - (ii) in paragraph 4(1) for "£633 per annum" there shall be substituted "£672 per annum".

## EXPLANATORY NOTE

#### (This note is not part of the Regulations.)

These Regulations amend the Further Education Teachers' Salaries Regulations (Northern Ireland) 1988 as amended and give effect from 1st September 1991 to an increase of  $6 \cdot 1\%$  in salaries and allowances for teachers in institutions of further education.

Revised salary scales and salary rates are set out in the Schedule.

The revised maximum allowances for certain heads of department are set out in regulation 2(a).

The revised rate of salary for unqualified teachers is set out in regulation 2(b).

Revised hourly rates of pay for part-time teachers are set out in regulation 2(c).

The provision for the protection of the salaries of full-time teachers in post has been updated in regulation 2(d).

These regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
