## MINERAL DEVELOPMENT

**Mineral Development (Applications, Fees and  
Model Clauses) (Amendment) Regulations  
(Northern Ireland) 1991**

*Made* . . . . . 8th March 1991

*Coming into operation* . . . . . 1st May 1991

The Department of Economic Development, in exercise of the powers conferred by section 49(1) of the Mineral Development Act (Northern Ireland) 1969(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel(c), hereby makes the following regulations:—

*Citation, commencement and interpretation*

1.—(1) These regulations may be cited as the Mineral Development (Applications, Fees and Model Clauses) (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 1st May 1991.

(2) In these regulations “the principal regulations” means the Mineral Development (Applications, Fees and Model Clauses) Regulations (Northern Ireland) 1970(d).

*Amendment of the principal regulations*

2. For regulation 5 of the principal regulations there shall be substituted the following regulations:—

“*Fees*

5.—(1) With every application there shall be forwarded to the Department the appropriate fee in accordance with the following Table:—

<i>Subject of Application</i>	<i>Amount of Fee</i>
Prospecting Licence	£450 for each licence
Mining Lease	£2,000 for each lease
Mining Licence	£2,000 for each licence
Mining permission	£450 for each permission
Mining facilities permit	£2,000 for each permit

(2) If any application is refused in its entirety the Department shall repay to the applicant one half of the fee paid in respect of the application.”

EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations amend the Mineral Development (Applications, Fees and Model Clauses) Regulations (Northern Ireland) 1970 by:

- (a) Increasing the fee payable on application for a prospecting licence and a mining permission under the Mineral Development Act (Northern Ireland) 1969 from £250 to £450.
- (b) Increasing the proportion of fees refundable to unsuccessful applicants from one quarter to one half.

These regulations also revoke regulation 2 of the Mineral Development (Applications, Fees and Model Clauses) (Amendment) Regulations (Northern Ireland) 1986.

The application fees for mining leases, mining licences and mining facilities permits remain unchanged.
