**The Housing Benefit (General) (Amendment)
Regulations (Northern Ireland) 1992**

Made 28th January 1992

Coming into operation—

<i>regulation 1</i>	1st April 1992
<i>regulations 2 to 5 to the extent that they relate to cases referred to in regulation 1(2)</i>	1st April 1992
<i>to the extent that they relate to any other case</i>	6th April 1992

The Department of Health and Social Services, in exercise of the powers conferred on it by Articles 21(1)(c), 22(6)(b) and 23(1), (8) and (9)(b) of the Social Security (Northern Ireland) Order 1986(a) and of all other powers enabling it in that behalf, with the consent of the Department of the Environment(b) so far as relates to matters with regard to which such consent is required, and after agreement by the Social Security Advisory Committee that proposals to make these regulations should not be referred to it(c), hereby makes the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Housing Benefit (General) (Amendment) Regulations (Northern Ireland) 1992 and shall come into operation as follows—

- (a) regulation 1 on 1st April 1992;
- (b) regulations 2 to 5 in any case to which paragraph (2) applies, on 1st April 1992 and in any other case, on 6th April 1992.

(2) This paragraph applies in any case where—

- (a) rent is payable at intervals of one month or any other interval which is not a week or a multiple thereof; or
- (b) payments by way of rates are not made together with payments of rent at weekly intervals or multiples thereof.

(3) In these regulations “the principal regulations” means the Housing Benefit (General) Regulations (Northern Ireland) 1987(d).

Amendment of regulation 18 of the principal regulations

2. In regulation 18(1) of the principal regulations (patients)—

- (a) in sub-paragraphs (a), (b) and (d)(ii) for “£13·00” there shall be substituted “£13·55”;
- (b) in sub-paragraphs (c)(i) and (d)(i) for “£10·40” there shall be substituted “£10·85”;
- (c) in sub-paragraph (c)(ii) for “£26·00” there shall be substituted “£27·10”.

Amendment of Schedule 2 to the principal regulations

3. In Schedule 2 to the principal regulations (applicable amounts)—

- (a) for Part I (personal allowances) there shall be substituted the Part set out in Schedule 1 to these regulations;
- (b) in Part II (family premium) in paragraph 3 for “£8·70” there shall be substituted “£9·30”;
- (c) for Part IV (amounts of premiums specified in Part III) there shall be substituted the Part set out in Schedule 2 to these regulations.

Amendment of Schedule 4 to the principal regulations

4. In Schedule 4 to the principal regulations (sums to be disregarded in the calculation of income other than earnings) in paragraph 22(b) for “£8·05” there shall be substituted “£8·60”.

Revocations

5. The Housing Benefit (General) (Amendment) Regulations (Northern Ireland) 1990(a) and the Housing Benefit (General) (Amendment No. 2) Regulations (Northern Ireland) 1991(b) are hereby revoked.

(This note is not part of the Regulations.)

These regulations further amend the Housing Benefit (General) Regulations (Northern Ireland) 1987.

Regulations 2 and 3 state the amount of the sums relevant to the applicable amount for the purposes of housing benefit. Regulation 3(a) and Schedule 1 set out the personal allowances and regulation 3(c) and Schedule 2 set out the premiums.

Regulation 4 increases the sum to be disregarded, in the calculation of income other than earnings, of a payment made to the claimant in certain circumstances.

Regulation 5 revokes the Housing Benefit (General) (Amendment) Regulations (Northern Ireland) 1990 and the Housing Benefit (General) (Amendment No. 2) Regulations (Northern Ireland) 1991.
