The Department of the Environment, being a department  $designated(\mathbf{a})$ for the purpose of section 2(2) of the European Communities Act 1972(b) in relation to the regulation of the type, description, construction or equipment of vehicles and the regulation and supervision of working conditions of persons engaged in road transport, in exercise of the powers conferred on it by section 56(1) and (5) of the Finance Act 1973(c), and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(d) as regards regulation 3, makes the following Regulations:

### Citation and commencement

1. These Regulations may be cited as the Passenger and Goods Vehicles (Recording Equipment) (Fees) (Amendment) Regulations (Northern Ireland) 1992 and shall come into operation on 1st October 1992.

#### *Interpretation*

2. The Interpretation Act (Northern Ireland) 1954(e) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

#### Regulations amended

3. In regulation 11 (fee for approval or renewal of approval of fitters and workshops) of the Passenger and Goods Vehicles (Recording Equipment) Regulations (Northern Ireland) 1979(f) in paragraph (a) for "£244" substitute "£287".

#### EXPLANATORY NOTE

### (This note is not part of the Regulations.)

These Regulations amend the Passenger and Goods Vehicles (Recording Equipment) Regulations (Northern Ireland) 1979 by increasing the fee payable for the grant of an approval of a fitter or workshop for the installation or repair of recording equipment (tachographs) from  $\pounds 244$  to  $\pounds 287$ .
