HOUSING; RATES**The Housing Benefit (General) (Amendment No. 2) Regulations (Northern Ireland) 1993***Made 29th March 1993**Coming into operation in accordance with regulation 1(1)*

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 122(1)(d) and 131(1) of the Social Security Contributions and Benefits (Northern Ireland) Act 1992(a) and of all other powers enabling it in that behalf, and after agreement by the Social Security Advisory Committee that proposals to make these regulations should not be referred to it(b), hereby makes the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Housing Benefit (General) (Amendment No. 2) Regulations (Northern Ireland) 1993 and shall come into operation as follows—

- (a) regulation 1 on 1st April 1993;
- (b) regulations 2 to 4 in any case to which paragraph (2) applies, on 1st April 1993 and in any other case, on 5th April 1993.
- (2) This paragraph applies in any case where—
 - (a) rent is payable at intervals of one month or any other interval which is not a week or a multiple thereof; or
 - (b) payments by way of rates are not made together with payments of rent at weekly intervals or multiples thereof.

(3) In these regulations “the principal regulations” means the Housing Benefit (General) Regulations (Northern Ireland) 1987(c).

(4) The Interpretation Act (Northern Ireland) 1954(d) shall apply to these regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment of regulation 18 of the principal regulations

2. In regulation 18(1) of the principal regulations (patients)—

- (a) in sub-paragraphs (a), (b) and (d)(ii) for “£13.55” there shall be substituted “£14.05”;

- (b) in sub-paragraphs (c)(i) and (d)(i) for “£10·85” there shall be substituted “£11·20”;
- (c) in sub-paragraph (c)(ii) for “£27·10” there shall be substituted “£28·10”.

Amendment of Schedule 2 to the principal regulations

3. In Schedule 2 to the principal regulations (applicable amounts)—
- (a) for Part I (personal allowances) there shall be substituted the Part set out in Schedule 1 to these regulations;
 - (b) in Part II (family premium) in paragraph 3 for “£9·30” there shall be substituted “£9·65”;
 - (c) for Part IV (amounts of premiums specified in Part III) there shall be substituted the Part set out in Schedule 2 to these regulations.

Revocations

4. Regulations 2 and 3 of the Housing Benefit (General) (Amendment) Regulations (Northern Ireland) 1992(a) and regulation 2 of the Income-Related Benefits (Amendment No. 2) Regulations (Northern Ireland) 1992(b) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations further amend the Housing Benefit (General) Regulations (Northern Ireland) 1987.

Regulations 2 and 3 state the amount of the sums relevant to the applicable amount for the purposes of housing benefit. Regulation 3(a) and Schedule 1 set out the personal allowances and regulation 3(c) and Schedule 2 set out the premiums.

Regulation 4 contains consequential revocations.
