## **Road Transport Licensing (Fees) (Amendment) Regulations (Northern Ireland) 1993**

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

The Department of the Environment, in exercise of the powers conferred by sections 9, 16(2) and 23(2) of the Transport Act (Northern Ireland) 1967(a) and now vested in  $it(\mathbf{b})$  and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(c), hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Road Transport Licensing (Fees) (Amendment) Regulations (Northern Ireland) 1993 and shall come into operation on 8th September 1993.

### Regulations amended

2. The Road Transport Licensing (Fees) Regulations (Northern Ireland) 1985(d) shall be amended as follows-

- (a) in regulation 3 (fees for road service licences) for " $\pounds 1.80$ " there shall be substituted "£2.55";
- (b) in regulation 5 (fees for road freight operators' licences) for "£3" there shall be substituted "£5.00"; and
- (c) in regulation 6(1) (road freight vehicle licence fees) for "£2.50 instead of  $\pounds 2.00^{\circ}$  there shall be substituted " $\pounds 3.00$  instead of  $\pounds 2.50^{\circ}$ .

# EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Road Transport Licensing (Fees) Regulations (Northern Ireland) 1985 by—

- (a) increasing the fee for a road service licence from £1.80 to £2.55 (per month or part of a month);
- (b) increasing the fee for a road freight operator's licence from £3.00 to £5.00 (per year); and
- (c) increasing the fee for a road freight vehicle licence from £2.50 to £3.00 (per month or part of a month).
