**Bus Permits (Designated Bodies) (Northern Ireland)
Order 1994**

Made 24th January 1994

Coming into operation 1st March 1994

The Department of the Environment, in exercise of the powers conferred on it by section 10B(6) of the Transport Act (Northern Ireland) 1967(a), and of all other powers enabling it in that behalf, and it appearing to the Department that the bodies designated under Article 2(1) are bodies concerned with education, religion, social welfare, recreation, or other activities to the benefit of the community, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Bus Permits (Designated Bodies) (Northern Ireland) Order 1994 and shall come into operation on 1st March 1994.

Designated bodies

2.—(1) The bodies specified in column (2) of the Schedule are hereby designated for the purposes of section 10B(6) of the Transport Act (Northern Ireland) 1967 as entitled to grant permits in relation to the use of a small bus.

(2) A body designated in said column (2) may grant permits to the classes of body specified in relation thereto in column (3).

Returns

3. Every designated body which grants permits shall send to the Department—

(a) a copy of every such permit, and

(b) particulars of any variation or revocation of every such permit

within one month of the grant, variation or revocation as the case may be.

EXPLANATORY NOTE

(This note is not part of the Order.)

Section 10A of the Transport Act (Northern Ireland) 1967 (as inserted by Article 3 of S.I. 1990/994 (N.I. 7)) exempts motor vehicles from the provisions of section 4(2) of that Act (requirement of road service licence) and Articles 59 and 60 of the Road Traffic (Northern Ireland) Order 1981 (as amended by S.I. 1991/197 (N.I. 3)) (licensing of public service vehicles and drivers, etc) where those vehicles are being used by designated bodies in accordance with the requirements of section 10B(2) of that Act.

This Order designates bodies which may grant permits in relation to the use of small buses under section 10B(6) of that Act.

A designated body may grant a permit to the bodies specified in relation to it in the Schedule (Article 2(2)).

Article 3 requires every designated body within one month to send the Department a copy of every permit granted by it and within the same period particulars of any variation or revocation.

A designated body may grant a permit to itself under Article 10B(3) of the said Act.
