ROAD TRAFFIC AND VEHICLES**Public Service Vehicles (Licence Fees) (Amendment)
Regulations (Northern Ireland) 1994***Made* 24th October 1994*Coming into operation* 1st December 1994

The Department of the Environment, in exercise of the powers conferred on it by Articles 61(1), 66(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(b) as regards regulation 2, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Public Service Vehicles (Licence Fees) (Amendment) Regulations (Northern Ireland) 1994 and shall come into operation on 1st December 1994.

Amendment of the Public Service Vehicles Regulations (Northern Ireland) 1985

2. In Schedule 7 to the Public Service Vehicles Regulations (Northern Ireland) 1985(c)—

- (a) in paragraphs 1(c) and 2(c) for “£29·20” there shall be substituted “£31”;
- (b) in paragraph 3(a) for “£9·30” there shall be substituted “£10”; and
- (c) in paragraph 4(a) and (b) for “£8·80” there shall be substituted “£9”.

Revocation

3. The Regulations specified in the Schedule are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Public Service Vehicles Regulations (Northern Ireland) 1985 by increasing the fee payable—

- (1) from £29·20 to £31 on initial application for a vehicle licence for a bus carrying 12 passengers or less or where the application is made within 21 days of the date of service of refusal and the bus is presented for re-inspection on a date and at a time appointed by the Department;
- (2) from £9·30 to £10 where re-application is made within 21 days from the date of service of a notice of a refusal and the taxi is presented for re-inspection on a date and at a time appointed by the Department; and
- (3) for a duplicate vehicle licence for a bus or a taxi from £8·80 to £9.

Regulation 3 revokes the Regulations listed in the Schedule.
