ROAD TRAFFIC AND VEHICLES

**Motor Vehicle Testing (Fees) (Amendment)
Regulations (Northern Ireland) 1994**

Made 24th October 1994

Coming into operation 1st December 1994

The Department of the Environment, in exercise of the powers conferred on it by Articles 33(2) and (6), 35(3), 36(4) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(b) as regards regulation 2, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Motor Vehicle Testing (Fees) (Amendment) Regulations (Northern Ireland) 1994 and shall come into operation on 1st December 1994.

Amendment of the Motor Vehicle Testing Regulations (Northern Ireland) 1989

2. The Motor Vehicle Testing Regulations (Northern Ireland) 1989(c) are amended as follows—

- (1) In regulation 8(d) (duplicate certificate) for “£8·80” there shall be substituted “£9”.
- (2) For Schedule 1 there shall be substituted the following Schedule—

(a) S.I. 1981/154 (N.I. 1); see Article 2(2) for the definition of “Department” and “prescribed”
(b) Formerly the Department of Finance. See S.I. 1982/338 (N.I. 6) Art. 3
(c) S.R. 1989 No. 234; relevant amending Regulations are S.R. 1991 No. 357, S.R. 1992 No. 379 and S.R. 1993 No. 393
(d) Regulation 8 was substituted by S.R. 1992 No. 379, reg. 2(1)

1. *Fee payable for test under regulation 3(2) or 5(2)*
 - (a) Motorbicycle..... £10·00
 - (b) Any other motor vehicle £17·00
2. *Fee payable for re-test under regulation 5(3)*
 - (a) Motorbicycle..... £7·50
 - (b) Any other motor vehicle £9·50

Fees on Appeals

- (a) Motorbicycle..... £10·00
- (b) Any other motor vehicle £17·00

PART III

Fees for Examinations under Article 35(2) or 36(3) of the Order

- (a) Motorbicycle..... £10·00
- (b) Taxi £28·00
- (c) Bus constructed or adapted to carry more than
12 passengers £40·60
- (d) Bus not so constructed or adapted £31·00
- (e) Large private passenger vehicle £20·00
- (f) Goods vehicle of 3,500 kgs maximum gross weight
or under £17·00
- (g) Goods vehicle over 3,500 kgs maximum gross
weight..... £31·00
- (h) Trailer..... £20·00
- (i) Any other motor vehicle £17·00''.

3. The Regulations specified in the Schedule are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Motor Vehicle Testing Regulations (Northern Ireland) 1989 by increasing fees payable as follows—

- (1) Duplicate vehicle test certificates from £8·80 to £9·00;
- (2) Tests—
 - (a) for any motor vehicle other than a motorbicycle from £16·65 to £17·00;
 - (b) where an application is made within 21 days from the date of service of a notification of refusal and the vehicle is presented for a re-test on the date and at a time appointed by the Department of the Environment, for any motor vehicle other than a motorbicycle from £9·30 to £9·50.
- (3) Appeals on refusal of a certificate, for any motor vehicle other than a motorbicycle from £16·65 to £17·00.

The fees for a test and for an appeal on refusal of a certificate for a motorbicycle remain unchanged.

- (4) Examinations under Article 35(2) (where vehicle has previously failed a roadside examination) or 36(3) (where driving of a defective vehicle on a road has been prohibited) of the Road Traffic (Northern Ireland) Order 1981—
 - (a) for a bus constructed or adapted to carry less than 12 people from £29·20 to £31·00;
 - (b) for a large private passenger vehicle from £19·30 to £20·00;
 - (c) for a goods vehicle of 3,500 kgs maximum gross weight or under from £16·65 to £17·00;
 - (d) for a goods vehicle over 3,500 kgs maximum gross weight from £30·80 to £31·00;
 - (e) for a trailer from £18·60 to £20·00; and
 - (f) for any other motor vehicle from £16·65 to £17·00.

The fees for these examinations for motorbicycles, taxis and buses constructed or adapted to carry more than 12 passengers remain unchanged.

Regulation 3 revokes the Regulations listed in the Schedule.
