Citation

1. This Order may be cited as the Registration (Land and Deeds) (1992 Order) (Commencement No. 2) Order (Northern Ireland) 1994.

Interpretation

2. In this Order, "the Order of 1992" means the Registration (Land and Deeds) (Northern Ireland) Order 1992 and any reference to a numbered Article or Schedule is to the Article of or, as the case may be, the Schedule to, that Order bearing that number.

Appointed day

3. The provisions of the Order of 1992 specified in the Schedule shall come into operation on 9th December 1994.

- (b) Article 41 (which relates to the vacation of pending actions registered in the Registry of Deeds);
- (c) Article 45 (which relates to sending documentation to the Registry of Deeds by post);
- (d) Article 47 (which relates to searches in the Registry of Deeds); and
- (e) certain repeals.
