The Department of Economic Development, in exercise of the powers conferred by Article 86(1), (2), (3), (4)(a), (5) and (7) of the Housing (Northern Ireland) Order 1981(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel(c), hereby makes the following Order:

## Citation and commencement

1. This Order may be cited as the Homes Insulation Scheme and Grants (Revocation) Order (Northern Ireland) 1994 and shall come into operation on 1st January 1995.

#### Revocation.

2.—(1) Subject to Article 3, the Orders listed in paragraph (2) are hereby revoked.

- (2) The Orders referred to in paragraph (1) are—
- (a) the Homes Insulation Scheme and Grants Order (Northern Ireland) 1991(d);
- (b) the Homes Insulation Scheme and Grants (Amendment) Order (Northern Ireland) 1994(e);
- (c) the Homes Insulation Scheme and Grants (Amendment No. 2) Order (Northern Ireland) 1994(f).

## Transitional provisions

3. The Orders listed in Article 2(2) shall continue to apply in relation to any applications for grant made before the coming into operation of this Order as if this Order had not been made.
