HEALTH AND PERSONAL SOCIAL SERVICES**The Health and Social Services Trusts (Public Meetings) Regulations (Northern Ireland) 1994**

Made 1st March 1994

Coming into operation 1st April 1994

The Department of Health and Social Services, in exercise of the powers conferred on it by paragraph 7(2) and (3) of Schedule 3 to the Health and Personal Social Services (Northern Ireland) Order 1991(a) and of all other powers enabling it in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Health and Social Services Trusts (Public Meetings) Regulations (Northern Ireland) 1994 and shall come into operation on 1st April 1994.

(2) In these Regulations, “the Order” means the Health and Personal Social Services (Northern Ireland) Order 1991.

Timing of the public meeting for the presentation of the audited accounts and annual report

2. For the purposes of paragraph 7(2) of Schedule 3 to the Order, the prescribed time for holding a public meeting of an HSS trust shall be on or before 30th September in every year, other than that which includes the operational date of the trust.

Other public meetings

3. For the purposes of paragraph 7(3) of Schedule 3 to the Order—

- (a) the circumstances in which an HSS trust shall hold a public meeting are those where it has received an auditor’s report made under the provisions of Article 92A(4) of the Health and Personal Social Services (Northern Ireland) Order 1972(b);
- (b) the time for holding the meeting is as soon as practicable, and in any event not later than three months, after the date on which the HSS trust received that report; and
- (c) the document which shall be presented at the meeting is that report.

Concurrent meetings

4. Nothing in these Regulations shall prevent a public meeting held pursuant to paragraph 7(2) of Schedule 3 to the Order in accordance with regulation 2 from being held on the same date and at the same time as a public meeting held pursuant to paragraph 7(3) of that Schedule in accordance with regulation 3.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations make provision for the timing of the public meetings at which HSS trusts shall present audited accounts and annual reports. They also provide that an HSS trust shall hold a public meeting to consider an auditor's report other than a report on the audited accounts and specify the timing of that meeting.
