# The Belfast Harbour (Variation of Limits) Order (Northern Ireland) 1995

To be laid before Parliament under paragraph 3(3) of Schedule I to the Northern Ireland Act 1974

The Department of the Environment, in exercise of the powers conferred by section 1(1) of the Harbours Act (Northern Ireland) 1970(a) and now vested in it(b), and of every other power enabling it in that behalf, and after consultation with the Belfast Harbour Commissioners, hereby makes the following order:

### Citation and commencement

1. This order may be cited as the Belfast Harbour (Variation of Limits) Order (Northern Ireland) 1995 and shall come into operation on 16th June 1995.

# Acts amended

2. In the Belfast Harbour Acts 1847 to 1967(c) for any reference to the seaward extremity of the weir downstream of the Queen Elizabeth bridge in connection with the limits of the Port and Harbour of Belfast or of the jurisdiction of the Belfast Harbour Commissioners there shall be substituted a reference to a line 5 metres downstream of the seaward extremity of, and parallel to, the Lagan bridge.

#### Revocation

**3.** The Belfast Harbour (Variation of Limits) Order (Northern Ireland) 1993(**d**) is hereby revoked.

#### EXPLANATORY NOTE

(This note is not part of the order.)

This order further amends the Belfast Harbour Acts 1847 to 1967 so as to reduce the limits of jurisdiction of the Belfast Harbour Commissioners in respect of the Port and Harbour of Belfast (which prior to the operative date of this order extended to the seaward extremity of the weir downstream of the Queen Elizabeth bridge).

The limits are reduced to a line 5 metres downstream of the seaward extremity of, and parallel to, the Lagan bridge.

Article 3 revokes the Belfast Harbour (Variation of Limits) Order (Northern Ireland) 1993.

# Medicines (Medicated Animal Feeding Stuffs) (Amendment) Regulations 1995

These Regulations have been made by the Minister of Agriculture, Fisheries and Food, the Secretaries of State respectively concerned with agriculture in Scotland and in Wales and the Department of Agriculture for Northern Ireland, acting jointly, in exercise of the powers conferred by sections 40 and 129(1) and (5) of the Medicines Act 1968 and section 2(2) of the European Communities Act 1972.

In pursuance of paragraph 11 of Schedule 4 to that Act these Regulations have been registered as a Northern Ireland statutory rule under the Statutory Rules (Northern Ireland) Order 1979. They are printed in full in the volume of United Kingdom Statutory Instruments for 1995 and have been numbered 799 in that series.
