Provision and Use of Work Equipment (Amendment) Regulations (Northern Ireland) 1995

Coming into operation

The Department of Economic Development, being the Department concerned(\hat{a}), in exercise of the powers conferred on it by Article 17(1) and (2) of, and paragraph 1(1), (2) and (3) of Schedule 3 to, the Health and Safety at Work (Northern Ireland) Order 1978(b) and of every other power enabling it in that behalf, after consultation in accordance with Article 46(1) of that Order with the Health and Safety Agency for Northern Ireland and such other bodies as appeared to the Department to be appropriate, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Provision and Use of Work Equipment (Amendment) Regulations (Northern Ireland) 1995 and shall come into operation on 13th March 1995.

Amendment of the Provision and Use of Work Equipment Regulations (Northern Ireland) 1993

2. For Schedule 1 to the Provision and Use of Work Equipment Regulations (Northern Ireland) 1993(c) there shall be substituted the Schedule set out in the Schedule to these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Provision and Use of Work Equipment Regulations (Northern Ireland) 1993 ("the 1993 Regulations") by substituting a new Schedule for Schedule 1 to the 1993 Regulations. Items of work equipment provided for use in the premises or undertaking of an employer must comply with any statutory provision which implements in Northern Ireland any of the relevant Community Directives listed in Schedule 1 to the 1993 Regulations which is applicable to such items of work equipment. The new Schedule 1 updates the references to a number of the listed Community Directives to take account of their amendment by later Directives, in particular Council Directive 93/68/EEC (O.J. No. L220, 30.8.1993, p. 1), known as the "CE Marking Directive".
