Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1995

Made 24th August 1995 . 25th September 1995 Coming into operation

The Department of Agriculture, in exercise of the powers conferred on it by sections 1(1), (2) and (2A) of the Seeds Act (Northern Ireland) 1965(a) and of every other power enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1995 and shall come into operation on 25th September 1995.

Revocation

2. The Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1994(b) are hereby revoked.

Amendment of the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982

3. For the Schedule to the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982(c) there shall be substituted:
