# Companies (Forms) Regulations (Northern Ireland) 1995

Made - - - - 5th October 1995 Coming into operation 16th November 1995

The Department of Economic Development, in exercise of the powers conferred on it by Article 603A(2) and 603D(4) of the Companies (Northern Ireland) Order 1986(1) and of every other power enabling it in that behalf, hereby makes the following Regulations:

# Citation and commencement

**1.** These Regulations may be cited as the Companies (Forms) Regulations (Northern Ireland) 1995 and shall come into operation on 16th November 1995.

#### **Prescribed Forms**

**2.** Forms 603a and 603c in the Schedule, with such variations as circumstances require, are forms hereby prescribed for the purposes of Articles 603A(2) and 603D(4) of the Companies (Northern Ireland) Order 1986.


