**The Child Support (1995 Order) (Commencement No. 2) Order
(Northern Ireland) 1995**

Made 18th December 1995

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(3) of the Child Support (Northern Ireland) Order 1995(a) and paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following Order:
