The Lord Chancellor, in exercise of the powers conferred by Articles 7(2), 22 and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(a) and now vested in him(b), hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 1995 and shall come into operation on 10th April 1995.

Revocation

2. The Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 1994(c) are hereby revoked.
