Roads (Speed Limit) (No. 5) Order (Northern Ireland) 1996

Made - - - - 15th April 1996 Coming into operation 27th May 1996

The Department of the Environment, in exercise of the powers conferred on it by Article 50(4)(c) of the Road Traffic (Northern Ireland) Order 1981(1) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Roads (Speed Limit) (No. 5) Order (Northern Ireland) 1996 and shall come into operation on 27th May 1996.

Speed restrictions on certain roads

2. The Department hereby directs that each of the roads and lengths of road specified in Schedule 1 shall be a restricted road for the purposes of Article 50 of the Road Traffic (Northern Ireland) Order 1981.

Revocations

3. The provisions described in Schedule 2 are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order makes the roads and lengths of road in Schedule 1 restricted roads, thereby imposing a 30 miles per hour speed limit on those roads.

The lengths of road to which the items in paragraphs 1 and 2 of Schedule 2 relate are now comprised in the length of road described in item No. 17 of Schedule 1.

The lengths of road to which the items revoked under paragraphs 3, 4, 5, 6, 7 (item Nos. 393 and 441), 8 and 9 of Schedule 2 relate are now comprised in greater lengths of road described in item Nos. 81, 13, 7, 82, 28, 77, 8 and 98 respectively of Schedule 1.
