**Marriage of Children (Consents) (Amendment)
Regulations (Northern Ireland) 1996**

Made - - - - *21st October 1996*
Coming into operation *2nd December 1996*

The Department of Finance and Personnel in exercise of the powers conferred by section 5(1) of the Marriages Act (Northern Ireland) 1954(1) and paragraph 2(1)(b) of Schedule 1 to the Northern Ireland Act 1974(2) and now vested in it(3) hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Marriage of Children (Consents) (Amendment) Regulations (Northern Ireland) 1996 and shall come into force on 2nd December 1996.

(2) In these Regulations “the principal Regulations” means the Marriage of Minors (Consents) Regulations (Northern Ireland) 1954.

Amendments to the principal Regulations

2.—(1) In the principal Regulations—

- (a) in regulation 1(2) for the word “minors” there shall be substituted the word “children”; and
- (b) in regulations 3 and 13, for the word “minor” there shall be substituted the word “child”.

(2) For the First Schedule of the principal Regulations, there shall be substituted the following Schedule—

(3) The functions of the Department of Finance were transferred to the Department of Health and Social Services by the Departments (N.I.) Order 1982, Article 5, Schedule 1 and transferred to the Department of Finance and Personnel by S.R. 1993/494
