B + E	<p>Combination of a motor vehicle and trailer where the tractor vehicle is in category B but the combination does not fall within that category.</p>	
C	<p>Any motor vehicle having a maximum authorised mass exceeding 3.5 tonnes, other than a vehicle falling within category D, F, G or H, including such vehicle drawing a trailer having a maximum authorised mass not exceeding 750 kilograms.</p>	
C1	<p>A sub-category of category C comprising motor vehicles having a maximum authorised mass exceeding 3.5 tonnes but not exceeding 7.5 tonnes, including such a vehicle drawing a trailer having a maximum authorised mass not exceeding 750 kilograms.</p>	
D	<p>Any motor vehicle constructed or adapted for the carriage of passengers having more than 8 seats in addition to the driver's seat, including such a vehicle drawing a trailer having a maximum authorised mass not exceeding 750 kilograms.</p>	
D1	<p>A sub-category of category D comprising motor vehicles having more than 8 but not more than 16 seats in addition to the driver's seat and including such a vehicle</p>

D + E	Combination of a motor vehicle and trailer where the tractor vehicle is in category D but the combination does not fall within that category.	B + E
D1 + E	A sub-category of category D + E comprising any combination of a motor vehicle and trailer where— (a) the tractor vehicle is in sub-category D1, (b) the maximum authorised mass of the trailer exceeds 750 kilograms but not the unladen
