PENSIONS

Pensions Increase (Review) Order (Northern Ireland) 1996

Made - - - - - *13th March 1996*

Coming into operation *8th April 1996*

Whereas by virtue of section 132 of the Social Security Administration (Northern Ireland) Act 1992⁽¹⁾ a direction⁽²⁾ has been given by the Department of Health and Social Services that the sums which are the additional pensions in the rate of long-term benefits are to be increased by a specified percentage;

Now, therefore the Department of Finance and Personnel, in exercise of the powers conferred by Article 69(1), (2), (5) and (5ZA) of the Social Security Pensions (Northern Ireland) Order 1975⁽³⁾ and now vested in it⁽⁴⁾ and of every other power enabling it in that behalf, hereby makes the following Order;

Citation and commencement

1. This Order may be cited as the Pensions Increase (Review) Order (Northern Ireland) 1996 and shall come into operation on 8th April 1996.

Interpretation

2.—(1) In this Order—

“the Act of 1971” means the Pensions (Increase) Act (Northern Ireland) 1971⁽⁵⁾;

“basic rate” and “derivative pension” have the meanings given by section 15(1)⁽⁶⁾ of the Act of 1971;

“existing Orders” means the Orders referred to in the Schedule;

“official pension” has the meaning given by section 5(1) of the Act of 1971;
 “the Order of 1975” means the Social Security Pensions (Northern Ireland) Order 1975;
 “pension authority” has the meaning given by section 7(1) of the Act of 1971;
 “qualifying condition” means one of the conditions laid down in section 3 of the Act of 1971(7);
 “relevant injury pension”, “substituted pension” and “widow’s pension” have the meanings given by section 15(1) of the Act of 1971.

(2) For the purpose of this Order the time when a pension “begins” is that stated in section 8(2) of the Act of 1971(8).

(3) Where, for the purposes of this Order, it is necessary to calculate the number of complete months in any period an incomplete month shall be treated as a complete month if it consists of at least 16 days.

Increases in certain pensions

3.—(1) The annual rate of an official pension may, if a qualifying condition is satisfied or the pension is a derivative or substituted pension or a relevant injury pension, be increased as set out in paragraphs (2) and (3) by the pension authority in respect of any period beginning on or after 8th April 1996.

(2) A pension beginning before 10th April 1995 may be increased by 3.9 per cent of the basic rate as increased by the amount of any increase under section 1 of the Act of 1971 or the existing Orders.

(3) A pension beginning on or after 10th April 1995 and before 8th April 1996 may be increased by 3.9 per cent multiplied by

$$\frac{A}{B}$$

where

A is the number of complete months in the period between the beginning of the pension and 7th April 1996 and B is 12.

Increase in certain lump sums

4. In respect of any lump sum or instalment of a lump sum which became payable before 8th April 1996 but after 9th April 1995 there may be paid an increase of 3.9 per cent of the amount of the lump sum or instalment (as increased by the amount of any increase under section 1 of the Act of 1971

or under the existing Orders) multiplied by

$$\frac{A}{B}$$

where:

a A is the number of complete months in the period between the beginning date for the lump sum (or, if later, 10th April 1995) and the date on which it became payable; and

b B is 12.

Reduction in respect of guaranteed minimum pensions

5. Where—

- (a) a person is entitled to a guaranteed minimum pension on 8th April 1996; and
- (b) entitlement to that guaranteed minimum pension arises from an employment from which (either directly or by virtue of the payment of a transfer credit) entitlement to the official pension also arises,

the amount by reference to which any increase in the rate of an official pension provided for by this Order is to be calculated shall be reduced by an amount equal to the rate of the guaranteed minimum pension unless the Department of Finance and Personnel⁽⁹⁾ in accordance with the provisions of Article 69A of the Order of 1975, otherwise directs.

6. The amount by reference to which any increase in the rate of a widow's or widower's pension provided for by this Order is to be calculated shall, where the pensioner becomes entitled on the death of the deceased spouse to a guaranteed minimum pension, be reduced in accordance with Article 69(5ZA)⁽¹⁰⁾ of the Order of 1975.

The Pensions Increase (Review) Order (Northern Ireland) 1995(34).

EXPLANATORY NOTE

(This note is not part of the Order.)

Under Article 69 of the Social Security Pensions (Northern Ireland) Order 1975 as amended, and as modified by Article 69A of the Order of 1975, the Department of Finance and Personnel is required to provide by Order for increases in the rates of public service pensions.

The increase to be made in the rates of such pensions is the percentage (or in some circumstances a fraction of the percentage) by which the Department of Health and Social Services has, by virtue of the provisions of section 132 of the Social Security Administration (Northern Ireland) Act 1992, increased the sums which are the additional pensions in long term benefits, namely the additional pension entitlements accruing to employees in respect of their earnings after 5th April 1978.

For pensions which began before 10th April 1995 the increase is 3.9%.

For pensions which began on or after 10th April 1995 the increases are computed under the formula set out in Article 69(1)(b) of the Order of 1975 and are as follows:

Pensions Beginning	percentage Increase
10th April 1995 to 23rd April 1995	3.9%
24th April 1995 to 23rd May 1995	3.58%
24th May 1995 to 23rd June 1995	3.25%
24th June 1995 to 23rd July 1995	2.93%
24th July 1995 to 23rd August 1995	2.6%
24th August 1995 to 23rd September 1995	2.28%
24th September 1995 to 23rd October 1995	1.95%
24th October 1995 to 23rd November 1995	1.63%
24th November 1995 to 23rd December 1995	1.3%
24th December 1995 to 23rd January 1996	0.98%
24th January 1996 to 23rd February 1996	0.65%
24th February 1996 to 23rd March 1996	0.33%
24th March 1996 onwards	Nil

A deferred lump sum which begins on or before 23rd March 1996 and which becomes payable after 8th April 1996 receives the same percentage increase as a pension which begins on the same date.

Article 4 of the Order provides for increases on certain deferred lump sums which become payable after 9th April 1995 and before 8th April 1996.

This Order also provides that the amount by reference to which any increase in the rate of an official pension is to be calculated shall be reduced by an amount equal to the rate of the guaranteed minimum pension entitlement deriving from the employment which gives rise to the official pension. This is required by Article 69(5) of the Social Security Pensions (Northern Ireland) Order 1975 but Article 69A of that Order empowers the Department of Finance and Personnel to direct that in respect of specified cases or classes of case either no such reduction shall be made or the reduction shall be less than the rate of the guaranteed minimum pension. Article 69(5ZA) applies to Article 69(5) to a widow's or widower's pension.
