Foyle Area (Control of Fishing) (Revocation) Regulations 1997

Citation and commencement

1. These regulations may be cited as the Foyle Area (Control of Fishing) (Revocation) Regulations 1997 and shall come into operation on 1st July 1997.

Revocation

2. The Foyle Area (Control of Fishing) Regulations 1977(**5**) and the Foyle Area (Control of Fishing) (Amendment) Regulations 1993(**6**) are hereby revoked.
