**Marketing of Potatoes (Amendment)
Regulations (Northern Ireland) 2000**

Made - - - - 12th October 2000

Coming into operation 13th November 2000

The Department of Agriculture and Rural Development⁽¹⁾, in exercise of the powers conferred on it by sections 3(3), 7(2) and 11(1) of the Marketing of Potatoes Act (Northern Ireland) 1964⁽²⁾ and of every other power enabling it in that behalf, and with the approval of the Department of Finance and Personnel⁽³⁾, hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 2000 and shall come into operation on 13th November 2000.

Amendment of the Marketing of Potatoes Regulations (Northern Ireland) 1989

2. The Marketing of Potatoes Regulations (Northern Ireland) 1989⁽⁴⁾ shall be amended as follows:—

- (a) In paragraph (1) of regulation 7 (Fees for the inspection of ware potatoes sent out of Northern Ireland) for “£3·35” there shall be substituted “£3·40”;
- (b) In regulation 8 (Fees for the examination of ware potatoes for sale in Northern Ireland) for “£3·35” there shall be substituted “£3·40”.

Revocation

3. The Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1994⁽⁵⁾ are hereby revoked.
