# The Occupational Pensions (Revaluation) Order (Northern Ireland) 2001

Made - - - - 23rd November 2001
Coming into operation 1st January 2002

Whereas the Secretary of State for Work and Pensions has made an Order(1) under paragraph 2(1) of Schedule 3 to the Pension Schemes Act 1993(2):

Now, therefore, the Department for Social Development, in exercise of the powers conferred by paragraph 2(1) of Schedule 2 to the Pension Schemes (Northern Ireland) Act 1993(3), and now vested in it(4), and of all other powers enabling it in that behalf, hereby makes the following Order:

#### Citation, commencement and interpretation

- **1.**—(1) This Order may be cited as the Occupational Pensions (Revaluation) Order (Northern Ireland) 2001 and shall come into operation on 1st January 2002.
- (2) The Interpretation Act (Northern Ireland) 1954(5) shall apply to this Order as it applies to an Act of the Assembly.

## Revaluation percentage for each revaluation period

**2.** For the purposes of paragraph 2(1) of Schedule 2 to the Pension Schemes (Northern Ireland) Act 1993, the revaluation percentage for each revaluation period specified in column 1 of the Schedule is the percentage specified opposite thereto in column 2.
