Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 2002

Made - - - - Coming into operation

2nd May 2002 30th May 2002

The Department of Agriculture and Rural Development(1), in exercise of the powers conferred on it by section 1 of the Seeds Act (Northern Ireland) 1965(2) and of all powers enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 2002 and shall come into operation on 30th May 2002.

(2) In these Regulations, "the Department" means the Department of Agriculture and Rural Development.

Fees

2. Every person who makes an application to the Department for the certification of seed potato crops under regulation 8(1) of the Seed Potatoes Regulations (Northern Ireland) 2001(**3**) shall forward with that application the appropriate fee in accordance with the Schedule.

Regulation 2

Fees for the certification of seed potato crops

Application	Fee
1. In the case of an application received by the Department on or before 30th May in any calendar year—	
(a) (a) where the total area of the crop does not exceed 1 hectare	£33·00
(b) (b) where the total area of the crop exceeds 1 hectare	£16.50 per half hectare or part of a half hectare
2. In the case of an application received by the Department after 30th May in any calendar year—	
(a) (a) where the total area of the crop does not exceed 1 hectare	£49·50

(b) (b) where the total area of the crop £24.75 per half hectare or part of a half hectare exceeds 1 hectare

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations prescribe the fees payable to the Department of Agriculture and Rural Development in respect of the certification of seed potato crops arising under the Seed Potatoes Regulations (Northern Ireland) 2001 (regulation 2 and the Schedule).

In the case of an application received by the Department on or before 30th May in any calendar year:---

- (a) where the total area of the crop does not exceed 1 hectare the fee is prescribed at $\pounds 33.00$;
- (b) where the total area of the crop exceeds 1 hectare the fee is prescribed at £16.50 per half hectare or part of a half hectare.

In the case of an application received by the Department after 30th May in any calendar year:-

- (a) where the total area of the crop does not exceed 1 hectare the fee is prescribed at $\pounds 49.50$;
- (b) where the total area of the crop exceeds 1 hectare the fee is prescribed at £24.75 per half hectare or part of a half hectare.

The Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 2000 were revoked by the Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 2001, which were subsequently annulled by the Northern Ireland Assembly.
