**Pharmaceutical Society of Northern Ireland (General)  
(Amendment) Regulations (Northern Ireland) 2003**

*Made* - - - - - *29th July 2003*

*Coming into operation* *1st September 2003*

The Council of the Pharmaceutical Society of Northern Ireland, in exercise of the powers conferred on it by Article 5 of the Pharmacy (Northern Ireland) Order 1976<sup>(a)</sup> and of every other power enabling it in that behalf, and with the approval of the Department of Health, Social Services and Public Safety<sup>(b)</sup> hereby makes the following Regulations: –

**Citation and commencement**

**1.**—(1) These Regulations may be cited as the Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2003 and shall come into operation on 1st September 2003.

(2) In these Regulations “the principal regulations” means the Pharmaceutical Society of Northern Ireland (General) Regulations (Northern Ireland) 1994<sup>(c)</sup>.

**Amendment of the principal Regulations**

**2.** In regulation 3 of the principal regulations (restoration fees) for “£50” there shall be substituted “£57”.

- 3.** In regulation 4 of the principal regulations (retention fees) –
- (a) in paragraph (1)(a) for “£150” there shall be substituted “£170”;
  - (b) in paragraph (2)(a) for “£69” there shall be substituted “£78”;
  - (c) in paragraph (2)(b) for “£55” there shall be substituted “£62”;
  - (d) in paragraph (2)(c) for “£25” there shall be substituted “£28”.

- (a) restoration of a person's name to the register (regulation 3);
- (b) retention fees payable in respect of members of the Society (regulation 4);
