Breeding Flocks, Hatcheries and Animal By-Products (Fees) Order (Northern Ireland) 2004

Made - - - - 29th March 2004
Coming into operation 26th April 2004

The Department of Agriculture and Rural Development(1), in exercise of the powers conferred on it by Article 50(1) of the Diseases of Animals (Northern Ireland) Order 1981(2) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Breeding Flocks, Hatcheries and Animal By-Products (Fees) Order (Northern Ireland) 2004 and shall come into operation on 26th April 2004.

Interpretation

2. In this Order -

"the Breeding Flocks Scheme" means the Poultry Breeding Flocks and Hatcheries Scheme (Northern Ireland) 1994(3); and

"the Regulations" means "the Animal By-Products Regulations (Northern Ireland) 2003"(4).

Fees

3. There shall be paid to the Department in respect of the transactions specified in column (2) of the Schedule the fees specified opposite thereto in column (3), such fees being payable within 14 days of demand.
