**The Health and Social Services Trusts (Establishment)
(Amendment) Order (Northern Ireland) 2007**

Made - - - - *9th March 2007*
Coming into operation *1st April 2007*

The Department of Health, Social Services and Public Safety⁽¹⁾, makes the following Order in exercise of the powers conferred by Article 10(1) of, and paragraphs 1 and 3A of Schedule 3 to the Health and personal Social Services (Northern Ireland) Order 1991⁽²⁾.

In accordance with Article 10(2) of that Order it has consulted with Health and Social Services Councils and such other persons and bodies as the Department considered appropriate.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Health and Social Services Trusts (Establishment) (Amendment) Order (Northern Ireland) 2007 and shall come into operation on 1st April 2007.

(2) In this Order—

(a) “relevant establishment orders” means—

- (b) “Belfast Trust Establishment Order” means the Belfast Health and Social Services Trust (Establishment) Order (Northern Ireland) 2006(7).

Amendment of the relevant establishment orders

2.—(1) Each of the relevant establishment orders shall be amended in accordance with paragraph (2).

(2) For Article 5(1) of each of the relevant establishment orders (*Directors of the trust*) there shall be substituted:-

“5. The trust shall have, in addition to the chairman, 7 non-executive directors and 5 executive directors.”

Amendment of the Belfast Trust Establishment Order

3. In Article 5(1) of the Belfast Trust Establishment Order (*Directors of the trust*) for “5” there shall be substituted “7”.
