The Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2007

Made - - - - 4th May 2007

Coming into operation 1st June 2007

The Council of the Pharmaceutical Society of Northern Ireland, in exercise of the powers conferred by Article 5 of the Pharmacy (Northern Ireland) Order 1976(1), makes the following Regulations with the approval of the Department of Health, Social Services and Public Safety(2).

Citation and commencement

- 1.—(1) These Regulations may be cited as the Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2007 and shall come into operation on 1st June 2007.
- (2) In these Regulations "the principal regulations" means the Pharmaceutical Society of Northern Ireland (General) Regulations (Northern Ireland) 1994(3).

Amendment of the principal regulations

- 2. In regulation 4 of the principal regulations (retention fees)—
 - (a) in paragraph (1)(a) for "£295" there shall be substituted "£319";
 - (b) in paragraph (2)(a) for "£135" there shall be substituted "£146";
 - (c) in paragraph (2)(b) for "£108" there shall be substituted "£117";
 - (d) in paragraph (2)(c) for "£49" there shall be substituted "£53".
