**The Pharmaceutical Society of Northern Ireland (General)
(Amendment) Regulations (Northern Ireland) 2007**

The Council of the Pharmaceutical Society of Northern Ireland, in exercise of the powers conferred by Article 5 of the Pharmacy (Northern Ireland) Order 1976⁽¹⁾, makes the following Regulations with the approval of the Department of Health, Social Services and Public Safety⁽²⁾.

Citation and commencement

1.—(1) These Regulations may be cited as the Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2007 and shall come into operation on 1st June 2007.

(2) In these Regulations “the principal regulations” means the Pharmaceutical Society of Northern Ireland (General) Regulations (Northern Ireland) 1994⁽³⁾.

Amendment of the principal regulations

2. In regulation 4 of the principal regulations (retention fees)—

- (a) in paragraph (1)(a) for “£295” there shall be substituted “£319”;
- (b) in paragraph (2)(a) for “£135” there shall be substituted “£146”;
- (c) in paragraph (2)(b) for “£108” there shall be substituted “£117”;
- (d) in paragraph (2)(c) for “£49” there shall be substituted “£53”.
