The Lord Chancellor, in exercise of the powers conferred on him by section 116(1) of the Judicature (Northern Ireland) Act 1978(1), after consultation with the Lord Chief Justice and with the concurrence of the Treasury, hereby makes the following Order:—

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Family Proceedings Fees (Amendment No.2) Order (Northern Ireland) 2007 and shall come into operation on 26th November 2007.
- (2) In this Order "the principal Order" means the Family Proceedings Fees Order (Northern Ireland) 1996(2).

Amendments to the principal Order

- 2. In the Schedule to the principal Order—
 - (a) after Fee no.1(b) insert the following fees:-

"(c)	On filing an answer/repl answer	y to a	petitio	on/ 100.00	The filed copy
(d)	Personal Application matrimonial interview	Fee	for	a 50.00	The requisition";

(b) after Fee no.4(q) insert the following fee:-"(r) On any application brought under form C2 (i) High Court 75.00 57.50"; and (ii) County Court

- (b) insert the fee for a C2 application in that part of the Schedule dealing with proceedings under the Children (Northern Ireland) Order 1995; and
- (c) delete the above fees where they were previously listed in the Schedule.

This Order does not increase or reduce any fees.
