# Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2008

Made - - - - 8th March 2008

Coming into operation - 7th April 2008

To be laid before Parliament

The Lord Chancellor makes the following Regulations in exercise of the powers conferred by Articles 7(2), 22 and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(a) and now vested in him(b):

#### Citation and commencement

1. These Regulations may be cited as the Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2008 and shall come into operation on 7th April 2008.

#### Revocation

**2.** The Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2007(c) are hereby revoked.

### Amendment to Schedule 2

**3.** For the table set out in Schedule 2 to the Legal Advice and Assistance Regulations (Northern Ireland) 1981(**d**) there shall be substituted the following table—
