The Motor Hackney Carriages (Belfast) (Amendment) By-Laws (Northern Ireland) 2008

Citation and commencement

1. These By-Laws may be cited as the Motor Hackney Carriages (Belfast) (Amendment) By-Laws (Northern Ireland) 2008 and shall come into operation on 1st August 2008.

By-Laws amended

2. For by-law 26(1) of the By-Laws relating to Motor Hackney Carriages standing or plying for hire made by the Council of the County Borough of Belfast on 4^{th} June 1951(1) there shall be substituted—

"26.—(1) The fares payable for the hire of a Motor Hackney Carriage within the prescribed limits shall be—

In assessing additional fares, every child under the age of 6 years and/or one child over 6 years and under 12 years shall be disregarded. Two children between the ages of 6 years and 12 years shall be counted as one passenger.".

3. By-law 2(4) of the Motor Hackney Carriages (Belfast) (Amendment) By-Laws (Northern Ireland) 2006(2) and the Motor Hackney Carriages (Belfast) (Amendment No. 2) By-Laws (Northern Ireland) 2006(3) are revoked.
