# Eel Fishing (Licence Duties) Regulations (Northern Ireland) 2010

Made	-	27th April 2010
Coming into operation	-	1st June 2010

The Department of Culture, Arts and Leisure (a) makes the following Regulations in exercise of the powers conferred by sections 15(1) and 19(1) of the Fisheries Act (Northern Ireland) 1966 (b) and now vested in it (c).

#### **Citation and commencement**

**1.** These Regulations may be cited as the Eel Fishing (Licence Duties) Regulations (Northern Ireland) 2010 and shall come into operation on 1st June 2010.

#### Licence duties

**2.** The licence duties payable to the Department of Culture, Arts and Leisure in respect of licences for the use of fishing engines for the taking of eels specified in column 1 of the Schedule are the amounts specified opposite in column 2 of the Schedule.

#### Revocation

3. The Eel Fishing (Licence Duties) Regulations (Northern Ireland) 2008 (d) are revoked.
