

EXPLANATORY MEMORANDUM TO

The Airfield Road Lower, Donnybrewer (Abandonment) Order (Northern Ireland) 2010

S.R. 2010 No. 241

1. Introduction

- 1.1. This Explanatory Memorandum has been prepared by the Department for Regional Development to accompany the Statutory Rule (details above) which is laid before the Northern Ireland Assembly.
- 1.2. The Statutory Rule is made under Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993 and is subject to the negative resolution procedure.

2. Purpose

- 2.1. The purpose of the Rule is to abandon a length of 506 metres of road including the level crossing at Airfield Road Lower, Donnybrewer.

3. Background

- 3.1. The abandonment has been requested by Translink to prevent dangerous level crossing violations.
- 3.2. Following the abandonment the railway track and bed will revert to the applicant, Translink. The remainder of the length of road is unregistered.

4. Consultation

- 4.1. The PSNI has been consulted and has no equipment in the area. Derry City Council was notified about the proposal and has advised that it has no objection.
- 4.2. A notice in respect of the proposed abandonment was published in the local press for 2 successive weeks, a notice was posted on site and the statutory undertakers were notified of the proposal. No objections were received.

5. Equality Impact

- 5.1. Consideration has been given to compliance with section 75 of the Northern Ireland Act 1998. No equality issues have been identified by the Department and no issues were raised following the publication of the notice in the press.

6. Regulatory Impact

- 6.1. A Regulatory Impact Assessment was not considered necessary as the proposal does not result in any cost or savings to business, charities or the voluntary bodies.

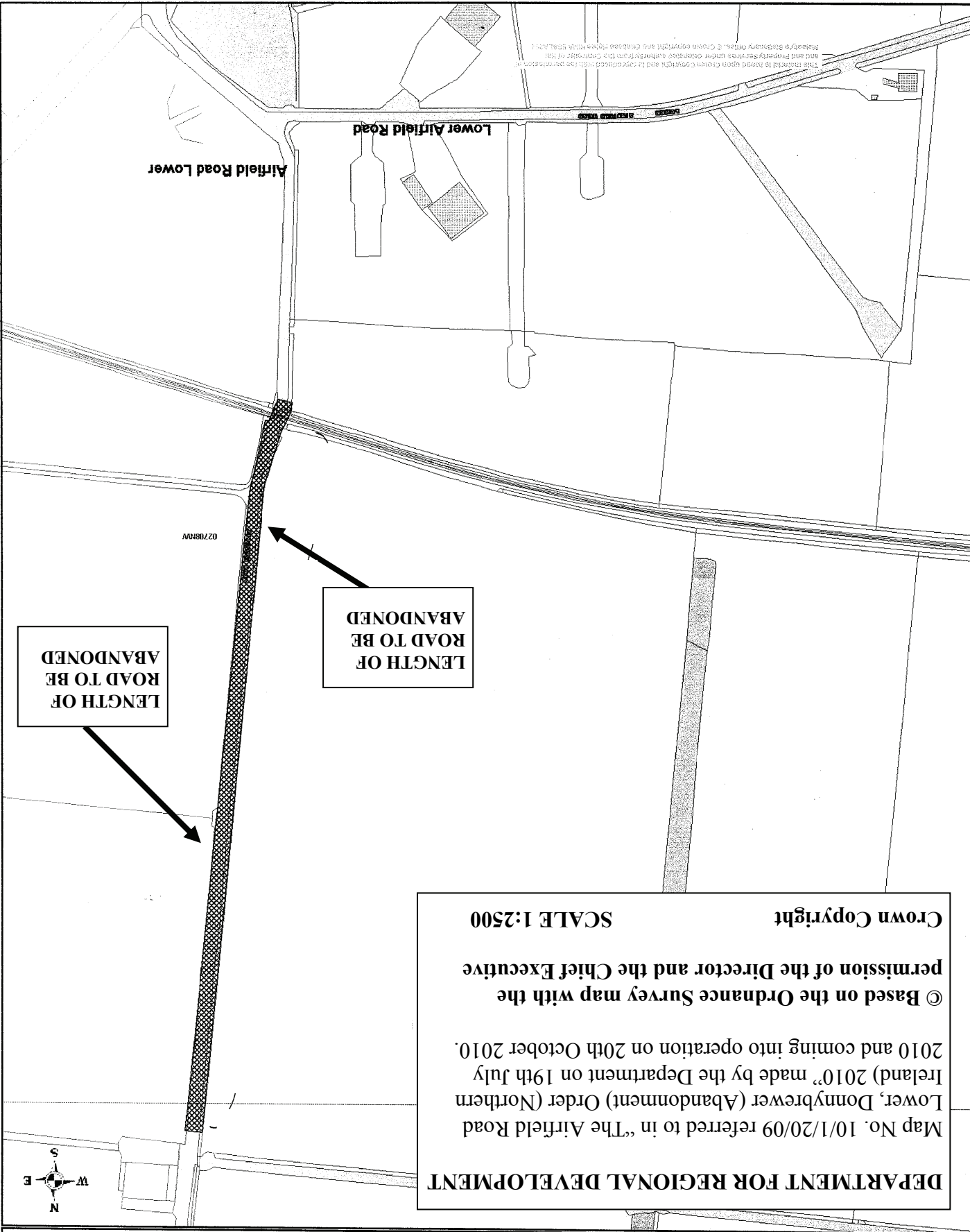
