**CRIMINAL LAW**

**Criminal Justice (Northern Ireland) Order 2008  
(Commencement No.6 and Transitional Provision) Order 2010**

*Made - - - - 13th February 2010*

The Secretary of State makes the following Order, in exercise of the powers conferred by Article 1 (4), and 100 (4) of the Criminal Justice (Northern Ireland) Order 2008 **(1)**.

**Citation and Interpretation**

**1.**—(1) This Order may be cited as the Criminal Justice (Northern Ireland) Order 2008 (Commencement No. 6 and Transitional Provision) Order 2010.

(2) In this Order “the 2008 Order” means the Criminal Justice (Northern Ireland) Order 2008.

**Commencement**

**2.** Article 92 of the 2008 Order shall come into operation on 26th February 2010.

**Transitional Provision**

**3.** Article 92 of the 2008 Order applies in relation to warrants referred to in sub-paragraphs (a) and (b) of paragraph (2) of that Article issued on or after 26th February 2010.
