The Scrapie (Fees) (Amendment) Regulations (Northern Ireland) 2010

Made - - - - 2nd March 2010
Coming into operation 1st April 2010

The Department of Agriculture and Rural Development—

- (a) being a Department designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to the common agricultural policy of the European Community in exercise of the powers conferred on it by the said section 2(2); and
- (b) in exercise of the powers conferred on it by section 56(1), (2) and (5) of the Finance Act 1973(3); and
- (c) with the consent of the Department of Finance and Personnel in respect of the powers conferred by that section 56,

makes the following Regulations.

Citation and commencement

1. These Regulations may be cited as the Scrapie (Fees) (Amendment) Regulations (Northern Ireland) 2010 and shall come into operation on 1st April 2010.

Interpretation

2.—(1) In these regulations—

"the Principal Regulations" means the Scrapie (Fees) Regulations (Northern Ireland) 2008(4).

Amendment of the principal Regulations

3.—(1) The principal Regulations shall be amended as follows.

- (b) the fee for the subsequent annual inspection is increased from £ 87.78 to £ 90.31.
