**Marketing of Potatoes (Amendment)  
Regulations (Northern Ireland) 2011**

*Made* - - - - *15th June 2011*

*Coming into operation* *1st September 2011*

The Department of Agriculture and Rural Development **(1)**, with the approval of the Department of Finance and Personnel **(2)**, makes the following Regulations in exercise of the powers conferred by sections 3(3), 7(2) and 11(1) of the Marketing of Potatoes Act (Northern Ireland) 1964**(3)**.

**Citation and Commencement**

**1.** These Regulations may be cited as the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 2011 and shall come into operation on 1st September 2011.

**Amendment of the Marketing of Potatoes Regulations (Northern Ireland) 1989**

**2.** The Marketing of Potatoes Regulations (Northern Ireland) 1989**(4)** shall be amended as follows—

- (a) in paragraph (1) of regulation 7 (Fees for the inspection of ware potatoes sent out of Northern Ireland) for “£3.90” there shall be substituted “£4.30”,
- (b) in regulation 8 (Fees for the examination of ware potatoes for sale in Northern Ireland) for “£3.90”, there shall be substituted “£4.30”.

**Revocation**

**3.** The Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 2005**(5)** are hereby revoked.

## **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations revoke and replace the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 2005.

The Regulations increase the fee payable for the inspection or examination of ware potatoes from £3.90 per tonne or part of a tonne to £4.30 per tonne or part of a tonne.
