

EXPLANATORY MEMORANDUM TO

The Welfare of Animal (Permitted Procedures by Lay Persons) Regulations (Northern Ireland) 2012

S.R. 2012 No. 153

1. Introduction

- 1.1. This Explanatory Memorandum has been prepared by the Department of Agriculture and Rural Development (DARD) to accompany the above-named Statutory Rule which was laid in draft before the Northern Ireland Assembly.
- 1.2. The Rule was approved by resolution of the Northern Ireland Assembly on 20th March 2012.
- 1.3. The Rule is made under powers in Section 5 of the Welfare of Animals Act (Northern Ireland) 2011 (“the Act”) and will come into operation on 2nd April 2012.

2. Purpose

- 2.1. The Welfare of Animals (Permitted Procedures by Lay Persons) Regulations (Northern Ireland) 2012 (“the Regulations”) specifies the acceptable practices which may be performed on animals by non-veterinarians. The Act provides an exemption for procedures carried out by a veterinary surgeon as these are regulated under the Veterinary Surgeons Act 1966 (as amended).
- 2.2. The Regulations list all procedures permitted to be carried out by a lay person which are considered necessary for the overall welfare or good management of an animal.

3. Background

- 3.1. Section 5 of the Act makes it an offence where a person carries out, or causes to be carried out, a prohibited procedure on a protected animal. A prohibited procedure is defined in the Act as one which involves interference with the sensitive tissues or bone structure of the animal.
- 3.2. These Regulations will bring into operation provisions which will allow lay persons who have received instruction, or have previous experience in a procedure, to carry out procedures on animals which are listed in the Regulations. Regulation 3 contains a general requirement that all permitted procedures be performed in accordance with any relevant requirement in the Schedules to the Regulations, in such a way as to minimise pain and

suffering caused to the animal, in hygienic conditions, and in accordance with best practice.

- 3.3. Regulation 4 contains an additional general exemption from the ban on prohibited procedures, for procedures performed in an emergency for the purposes of saving life or relieving pain of a protected animal.
- 3.4. Regulation 5 permits continuation of the practice of removal of tissue, hair or feathers for genetic analysis.
- 3.5. Schedules 1 – 11 specify the permitted procedures which may be carried out by a lay person on each species of animal. Within Part I of each schedule the procedures have been further separated under headings “Identification Procedures”, “Procedures for the Control of Reproduction” and “Other Management Procedures”. Where necessary any additional conditions are specified in Part II of each schedule.

4. Consultation

- 4.1. A 12 week consultation was undertaken for these Regulations from 1st July 2011 to 23rd September 2011.
- 4.2. There were 25 responses to the consultation. Overall the Regulations were welcomed by all stakeholders and there was significant support for the majority of the proposals in them. A summary of consultation responses has been placed on the DARD website.
- 4.3. The consultation proposed that all procedures which had historically been permitted to be carried out by lay persons should continue with the exception of hot branding of horses. The proposal to ban the practice of hot branding of horses was welcomed and supported by all respondents to the consultation.
- 4.4. Consultation responses led to a review of the policy in relation to some outdated methods of identification now that microchipping is widely accepted as a reliable method of identification. As a result ear clipping for any species of animal, ear notching of pigs and tagging of cats and dogs were removed from the draft Regulations and will therefore be banned. In addition since the consultation implantation of a subcutaneous hormone has been added to the list of permitted procedures for sheep.

5. Equality Impact

- 5.1. Under Section 75 of the Northern Ireland Act 1998 DARD has considered and assessed the Regulations for any equality implications. A full equality impact assessment has not been carried out as the policy has been screened out. No equality differentials are foreseen on Section 75 groups. A copy of the

6. Regulatory Impact

- 6.1. A Regulatory Impact Assessment has not been carried out as the Regulations do not have any impact for businesses, charities or voluntary bodies. The Regulations will not introduce any new constraints or other limitations on businesses or other bodies and the resulting impact of the introduction of these Regulations on such business or other bodies should therefore be zero.

7. Financial Implications

- 7.1. The Regulations do not have any financial implications for the Department or stakeholders.

8. Section 24 of the Northern Ireland Act 1998

- 8.1. The Regulations set out the acceptable practices that may be performed on animals by non-veterinarians. The Regulations are therefore deemed to comply with the requirements of section 24 of the Northern Ireland Act 1998.

9. EU Implications

- 9.1. Not applicable.

10. Parity or Replicatory Measure

- 10.1. This legislation applies to Northern Ireland and there is no impact on any other devolved administration.
- 10.2. In England provisions on permitted procedures are contained in the Mutilations (Permitted Procedures) (England) Regulations 2007 (as amended).
- 10.3. In Wales provisions on permitted procedures are contained in the Mutilations (Permitted Procedures) (Wales) Regulations 2007 (as amended).
- 10.4. In Scotland provisions on permitted procedures are contained in the Prohibited Procedures on Protected Animals (Exemptions) (Scotland) Regulations 2007 (as amended).
- 10.5. In Ireland a new Animal Health and Welfare Bill is being drafted and is likely to include provisions regarding the mutilation of an animal.
